Vide this office letter dated 27.09.2018; it was informed that RITES has introduced a facility of downloading Test reports from RITES website by all concerned. However, after issues were raised, Inspecting Engineers were asked to give hard copy of test reports to Vendors for onward submission to Consignee along with consignee copy of IC.

Recently, Railway Board have issued instructions vide letter no. 2000/RS (G)/379/2 dated 02.01.2019 regarding pre- dispatch inspection of stores. Para 3.2 of the instructions inter alia state that

"Digitally signed IC and relevant Test Certificate / Test report/ Lab report etc. available on RITES web site satisfy all the requirement of IC and report as per Information Technology Act 2000. There is a no need for hard copy of IC and the lab/ test reports to be submitted to various authorities including consignee."

In view of the above, RITES Inspecting Engineers have been directed to upload test reports along with Inspection Certificate issued by them on RITES website. Following inspection records have been identified for uploading on RITES website:

- i) Duly filled Inspection and test plan (check sheet) excluding Dimensional report.
- ii) Lab Report of Testing witnessed by the Inspecting Engineer at Manufacturer's works as part of Acceptance Test during the process of inspection.
- Lab report for samples which have been taken by the Inspecting Engineer as part of Acceptance Test and sent to outside Lab during the process of Inspection.
- iv) Manufacturer's Test Certificate or Lab reports attached with such Manufacturer's Test certificate whenever the Inspection is done against Manufacturer's Test Certificate in terms of conditions of the PO.
- v) Any other document required to be submitted to Consignee as per P.O/ contract requirement

Inspecting Engineers have also been instructed to stop physical dispatch of Test reports to consignees directly or through vendors from 15.04.2019. Test reports will be visible to all Consignees at the site address given below -

For downloading the Test reports, the Purchaser/ Consignees will be required to access the above link and following steps to be taken thereafter:

- 1. Select Client as Railways
- 2. Select Name of Zonal Railways/PUby whom PO has been issued
- 3. Submit PO date (in specified format)

From the drop down list select the relevant PO to view details. On extreme right is the option to download relevant Test report and Inspection Certificate. Please note that for material accepted in multiple installments, all copies of documents will be visible & relevant copy of IC & test report can be downloaded,

Further, it has been decided that as Inspection Certificates are being uploaded on RITES website, hard copies of Inspection Certificate will not be dispatched from 01.05.2019. However copy of Inspection Certificate for Contractor with bill, Contractor for consignee and Paying Authority with RITES bill will continued to be issued in physical form as these will be required for billing and lot identification purpose. We are working with CRIS to develop interface to submit RITES invoice digitally. With successful trial of digital invoicing, the way forward is to dispense with all physical copies of Inspection Certificates and shift completely towards digital Inspection Certificate.
